FILMING – IMPORTANT POINTS TO NOTE

Filming in Hong Kong is hassle free! Here are the most important points to note:

Filming in public places and private venues

- Location filming in public places does not generally require permission from the Government but you need to inform the TV and Films Liaison Section, Police Public Relations Branch (PPRB) of the Hong Kong Police Force.
- Location filming in public places under Government control, e.g. public facilities, Government properties and land, requires permission from the relevant Government Departments.
- Location filming in venues managed by private organisations requires permission from the relevant venue owners/operators.

- Contact the FSO to arrange:
 - filming which requires special traffic arrangements in public places

closure of public carriageways
parking of filming vehicles
occupation of parking spaces
hiring of the Hong Kong Police Force for intermittent
traffic control

- filming with large props/filming equipment in public places

Filming Props

- O Permits are required for:
 - use of replica uniforms and accoutrements of Government forces, modified firearms, blank ammunition, pyrotechnics or special effects materials, helicopter and unmanned aircraft system
 - use of replicas of logos, uniforms, badges or staff identity cards of government departments, or identification documents such as passports issued by the government for filming
 - reproduction of Hong Kong currency notes/coins

- filming involving lion/dragon/unicorn dance or playing musical instruments in public areas

Use of Special Effects Materials

- Ounder the Hong Kong Entertainment Special Effects Ordinance (Cap. 560), a discharge permit issued by the Entertainment Special Effects Licensing Authority (ESELA) is required for any use of special effects materials to produce entertainment special effects in films, commercials, television programmes and other similar productions. Any person who uses such materials is also required to obtain a special effects operator licence from the ESELA.

More Points to Note

Hong Kong is a very crowded city, film crews should pay particular attention to the following when filming:

- Obstruction of public places
 Location filming in any public place must not obstruct,
 cause inconvenience to or endanger members of the public and/or their vehicles.
- Road traffic and parking
 All filming vehicles on public roads must observe the Road Traffic Regulations.
- Noise control
 It is an offence to make or cause any noise which is
 a source of annoyance in a public place or in any
 domestic premises between 11pm and 7am, or at
 any time on public holidays under the Noise Control
 Ordinance (Cap. 400).

Tips for Very Rare Occasions

Hong Kong is a very safe place for location filming. It is very rare that film crews are approached by criminal elements for payment before they can conduct filming. If it is so unfortunate that you encounter such situation, you should:

- o keep calm
- o report to the police on the spot (Emergency Hotline 999)
- o refuse to pay
- o remember details of the incident, e.g. the person(s) who demanded payment, witness(es) etc.
- o be prepared to testify in court if the police make an arrest

YOUMAY WISH TO KNOW THESE

Below are some Government regulations that are relevant to filming in Hong Kong:

Entering Hong Kong – Immigration Control and Visas

If you are a member of overseas film crew...
In general, unless a person has the right of abode or right to land in Hong Kong, he/she requires a visa/ entry permit to take up employment, establish or join in business, study, take up residence or stay in Hong Kong as a visitor longer than the allowed visa-free period. Persons who need a visa/entry permit should obtain it before travelling to Hong Kong.

Overseas film crew members, who enjoy the visa waiver concession to visit Hong Kong for a stay within the entitled visa-free period, may generally engage in business-related activities, such as location scouting and attending business meetings. Whether employment visas/entry permits are required depend mainly on the nature of activities in Hong Kong. It is advisable to check with the Immigration Department (ImmD) before coming to Hong Kong. If employment visas/entry permits are required, members of a film crew should apply for individual visas/entry permits, though they may submit a joint application.

To get a visa/entry permit, please submit the completed application form and supporting documents (e.g. employment contract or letter of appointment) to

the ImmD directly by post or through a local sponsor. A local sponsor, usually the employing company, will be required to vouch for the applicant. The normal processing time is four weeks upon receipt of all the required documents. Alternatively, you can contact the nearest Chinese diplomatic and consular mission in your place of residence, the Immigration Division of the Office of the Government of the HKSAR in Beijing or the Immigration Division of the Hong Kong Economic and Trade Office in Shanghai.

If you are a Mainland resident...

Members of film crews who are Mainland residents may apply for employment in Hong Kong under the Admission Scheme for Mainland Talents and Professionals. Applications must be submitted by the employing organisation, which should be a company registered in Hong Kong. Completed application forms and all supporting documents should be submitted by the employer either in person or by post to the ImmD. The normal processing time is four weeks upon receipt of all the required documents. Successful applicants will be issued an entry permit label and they should apply for an Exit-entry Permit for Travelling to and from Hong Kong and Macao and a relevant exit endorsement from the relevant Mainland authorities.

Entering Mainland China

If you wish to visit Mainland China, it is best to check with the nearest Chinese diplomatic and consular mission in your place of residence before departure. For visa requirements for entry to Mainland China and addresses of Chinese diplomatic and consular missions, please visit the website of the Ministry of Foreign Affairs of the People's Republic of China at www.fmprc.gov.cn/mfa_eng.

Customs and Excise

Except with an import licence issued by the authorities concerned, no one should import prohibited/controlled items such as dangerous drugs, psychotropic substances, controlled chemicals, antibiotics, arms, ammunition, weapons, fireworks, strategic commodities, rough diamonds, animals, plants, endangered species, telecommunication equipment, game, meat, poultry, eggs and powdered formula to Hong Kong. Any person who arrives in Hong Kong via a specified control point in possession of a large quantity of currency and bearer negotiable instruments (CBNIs) (i.e. CBNIs of a total value more than HK\$120,000) must make a written declaration to

a Customs officer at the Red Channel of a customs control point. For details, please visit the webpage at www.customs.gov.hk/en/passenger_clearance/instruments/index.html.

ATA Carnets

Film crews entering Hong Kong are not subject to any customs duties on the importation of equipment or other specific duties in connection with their work.

However, if the equipment is covered by an ATA Carnet, film crews should approach the Customs Duty Officer for endorsement upon arrival and prior to departure. Baggage and equipment may be subject to customs check as per regular passengers.

Animals

A special permit or an import permit from the Agriculture, Fisheries and Conservation Department (AFCD), depending on the country of origin is from overseas or from the Mainland, respectively, must be obtained before animals and birds can be imported into or transshipped via Hong Kong. The permit is valid for six months from the date of issue and is suitable for one consignment only. Dogs and cats imported from countries or places with high risk of rabies are subject to a minimum quarantine period of four months in two animal management centres under the AFCD. Other species of animals may also be

subjected to quarantine measures depending on the specific permit terms pertaining to the particular species.

In Hong Kong, animals are protected under the Prevention of Cruelty to Animals Ordinance (Cap. 169) which prohibits any cruelty to or negligence of any animal that would cause them unnecessary suffering at any time. The Society for the Prevention of Cruelty to Animals (Hong Kong) (SPCA(HK)) urges filmmakers to protect the mental and physical well-being of animals, to understand and consider an animal's natural habits when filming and to make every effort to ensure a stress-free filming environment when animals are involved. No animals shall be harmed or killed for filming purposes. They should only be required to perform reasonable tasks and should be well trained if used for stunts or special effects sequences. A trained animal handler or vet should be present and has the responsibility to halt animal use if needed. Contact the SPCA(HK) for more information.

Weapons and Ammunition

Possession of any prohibited weapons, arms and ammunition is not permitted in Hong Kong (except with proper authorisation). Offenders face strict penalties. These weapons include knives incorporating mechanical

or electronic devices, gravity knives, gravity-operated batons, knuckle-dusters, Chinese-style throwing darts and fighting irons, and spring-loaded steel batons. Arms also include electric stun devices, chemical irritant sprays such as mace, harpoons and spear guns.

Modified Firearms and Blank Ammunition

No genuine arms and ammunition can be used for filming in Hong Kong. Modified firearms and blank ammunition for filming must be licensed or exempted from licence by the Commissioner of Police.

Anyone planning to use or handle modified firearms and blank ammunition for filming must contact the Police Licensing Office to obtain an Exemption Permit at a prescribed fee, at least ten working days beforehand. A separate approval notice issued by the PPRB should be sought for the use of modified firearms and blank ammunition for filming, on each occasion. The completed application form should be submitted three working days before filming. If shooting is to take place inside a private or Government property, a copy of the agreement for such use is needed.

Fireworks and Explosives

Under the Dangerous Goods Ordinance (Cap. 295), it is an offence to possess, conveyance, manufacture or use any fireworks, firecrackers, pistol caps and party-poppers or other explosives without a licence. For enquiries, please contact the Mines Division of the Civil Engineering and Development Department.

Under the Entertainment Special Effects Ordinance (Cap. 560), it is an offence to supply, convey, store or use any pyrotechnic special effects materials without relevant licences and permits. For information on the relevant licences/permits, please check out the website of Special Effects Licensing Unit (www.createhk-esela.gov.hk/eng).

Labour Laws

Hiring of Child Entertainers

Under the Employment Ordinance (Cap. 57), a "child" is defined as a person under the age of 15 years. The Employment of Children Regulations, made under the Employment Ordinance, prohibit the employment of children in industrial undertakings and regulate the employment of children in non-industrial establishments. It is noted that children of different ages may be employed as child entertainers to serve the needs of

the entertainment industry or related fields. For the development of art or training, the Commissioner for Labour may permit such employment by granting exemption from certain provisions of the Employment of Children Regulations. An employer intending to employ child entertainers should apply to the Commissioner in writing before the commencement of the employment. To ensure that the children's schooling is not interfered and their well-being including safety, health and morals are not adversely affected, the Commissioner will impose specific conditions and restrictions upon the grant of permissions. Employees' Compensation


According to the Employees' Compensation Ordinance (Cap. 282), no employer shall employ any employee in any employment unless there is in force a policy of insurance to cover his liabilities under the laws (including the common law) for injuries at work in respect of all his employees, irrespective of the length of employment contract or working hours, full-time or part-time employment. HONG KONG: THE ESSENTIALS

Travel Information

Accommodation

Hong Kong has a wide variety of accommodations which suit the budgets for different visitors. Hotels/guesthouses licensed by the Home Affairs Department can be found at www.hadla.gov.hk/en/hotels/search_h.html. There are also some moderately priced youth hostels or hostels operated by voluntary organisations such as Caritas Hong Kong, YMCA, YWCA and the Scout Association of Hong Kong. Contact the Hong Kong Tourism Board or visit its website at www.discoverhongkong.com/eng/plan.html for information.

Electricity supply

Hong Kong's power supply is at 50 Hz alternating current while the voltage is 220 volts single phase and 380 volts three phases. The majority of electrical outlets in Hong Kong take a three-pronged UK-style plug.

Currency

The Hong Kong dollar (HK\$) is freely convertible and is pegged to the US dollar at a narrow range around HK\$7.80 to US\$1. There is no inflow or outflow limitation on the amount of currency.

Language

Chinese and English are the official languages of Hong Kong. The majority of Hong Kong people speak Cantonese but Putonghua (i.e. Mandarin) and English can be used for daily communication as well.

Weather Information

Hong Kong Observatory (HKO) provides weather information, forecasts and warnings on hazardous weather for public information through a variety of dissemination channels including the HKO's website (www.hko.gov.hk and www.weather.gov.hk), the 187 8200 Dial-a-weather service, TV and radio channels, etc.


Festivals, Traditions, Festive Seasons and Holidays

Hong Kong enjoys the best of East and West in regard to festivals and holidays. The Lunar New Year (Chinese New Year), usually in late January or early February, is the most important festival in the year.

Festivals

Other traditional festivals that are still celebrated with colourful and vibrant activities include:

- Spring Lantern (Chinese Valentine's Day) that is the 15th day of the first lunar month which is celebrated with family gatherings and eating of glutinous rice balls together and with beautiful lanterns display in major parks
- Birthday of Tin Hau (the Queen of Heaven and the Goddess of the Sea) (the 23rd day of the 3rd lunar month, usually in April or May) – on top of celebrations in different Tin Hau Temples in Hong Kong, there are parades of dragon and lion dances and exchanges of fa pau (paper floral tributes)
- Birthday of Tam Kung (a patron of boat people) (4th lunar month) – it is celebrated by fishermen and the coastal community. There are colourful parades of dragon and lion dances by the Tam Kung Temple in Shau Kei Wan on Hong Kong Island



- Tuen Ng Festival (Dragon Boat Festival) (on the 5th day
 of the 5th lunar month, usually in June) the waters around
 Hong Kong come alive with the sounds of beating drums
 of dragon boat racing competitions
- O Cheung Chau Jiao Festival (Bun Festival) (usually in May) the festival is held on Cheung Chau Island (an hour's ferry ride from Central). It features a "floating colours" parade in which child performers dressed in costumes of mythical or modern characters suspended by rods and wires, seemingly floating in the air. The Bun Scrambling Competition is the festival's highlight
- Hungry Ghost Festival (the 7th lunar month) for the Chiu Chow community, it is Yu Lan Festival. Paper offerings and incense are burnt on the road side for the ghosts and ancestors to use in the netherworld. Temporary bamboo stages are set up in different districts for Chinese opera performances
- Mid-Autumn Festival (the 15th day of the 8th lunar month) –
 it is celebrated with family gatherings during the
 full moon, eating mooncakes and displaying lanterns.
 The fire dragon dance in Tai Hang in Causeway Bay
 is a spectacular event in which a dragon inserted with
 joss sticks is paraded around the area.

Traditions

Another interesting tradition is "petty person beating" which takes place under Canal Road Flyover in Causeway Bay on the Hong Kong Island where old ladies sitting in front of small altars with burning incense sticks, chanting and beating paper voodoo dolls with a shoe. It mainly takes place at the beginning of March during the day of Awakening of Insects, the third solar term. But nowadays, you can find the ritual practised throughout the year.

Festive Seasons

Around late-November, many buildings put up festive lights in preparation for Christmas, New Year and Lunar New Year.
